NEW ACHIEVER AWARD

The New Achiever Award was introduced as a part of the Association's 75th Anniversary observance in 1984 when it was established to identify and honor emerging family and consumer sciences professionals who have exhibited the potential to make significant contributions to the field through their involvement with AAFCS.

LEADER AWARD

The Leader Award was introduced as a part of the Association's 75th Anniversary observance in 1984 when it was established to identify and honor family and consumer sciences professionals who have made significant contributions to the field through their involvement with AAFCS.

### DISTINGUISHED SERVICE AWARD

The Distinguished Service Award (DSA) was established by the American Home Economics Association (AHEA) Foundation in 1979 as a living tribute to members of AHEA (now AAFCS) to recognize superior achievements in family and consumer sciences, outstanding contributions to the family and consumer sciences profession, and sustained association leadership at both state and national levels. Nominations are due in August, and DSA recipients are honored at the Annual Conference in the following year.

### AAMFT Awards

#### Cumulative Contribution to Family Therapy Research Award

- AAMFT honors one member each year for continuous, meritorious and generative contribution to research in family therapy. AAMFT members may nominate other members for this award. Nominators must submit a curriculum vitae of the person being nominated and a written statement of ways that the nominee demonstrates a cumulative contribution to family therapy research and meets one or more of the following criteria:

1. Development of original theory that stimulates the systematic study of important issues in family therapy;
2. Superior design and execution of research programs;
3. Pioneering explorations of new research areas;
4. Significant contribution to substantive knowledge in the field;
5. Codification of a field of inquiry;
6. Conceptual integration;
7. New techniques of measurement, data collection and data analysis.

#### Outstanding Contribution to Marriage and Family Therapy Award

- Since 1991, AAMFT has honored up to three members each year for outstanding contributions to the field of marriage and family therapy. The award consists of a plaque, up to \$1,000 per recipient for travel reimbursement to the Annual Conference, and the conference registration fee will be waived. AAMFT will reimburse up to the total of \$1,000 for economy class airfare, transportation to/from airport/hotel, meals per AAMFT allowances for the one day of the ceremony, and one night's hotel stay at one of the AAMFT conference hotels (at the special discounted rate) for the night of the ceremony.

### Outstanding Volunteer Service Award

- AAMFT recognizes up to two members annually who exhibit exceptional leadership and commitment to the association through outstanding volunteer efforts, demonstrating generative contributions through areas such as engagement programs, mentoring, and association growth. Nominators must submit a curriculum vitae of the person being nominated and a written statement of ways that the nominee demonstrates exceptional leadership and commitment to the association. The award consists of a plaque presented at our Annual Conference. The conference registration fee will also be waived for the award recipient(s).

### Excellence in the Media Award

This award was established in order to recognize and encourage the use of media to:

1. Effectively portray marriage and family therapists' exceptional and substantive contribution to health and mental health care;
  2. Promote the profession of marriage and family therapy to the public;
- or
3. Significantly contribute to family well-being.

Submissions are encouraged from all popular media, including newspapers, magazines, radio, television, blogs, and social media. Entries must have been published or broadcast in the previous year.

The award consists of a plaque, up to \$500 travel reimbursement to the Annual Conference, and the conference registration fee waived. AAMFT will reimburse up to the total of \$500 for economy class airfare, transportation to/from airport/hotel, meals per AAMFT allowances for the one day of the ceremony, and one night's hotel stay at one of the AAMFT conference hotels (at the special discounted rate) for the night of the ceremony. You must submit itemized receipts upon your return from the conference.

### Training Award

- This award is granted by AAMFT and honors members and/or training programs for significant contributions to the advancement of the field of marriage and family therapy by encouraging and training the next generation of marriage and family therapy researchers and/or practitioners. The award consists of a plaque presented at our Annual Conference. The conference registration fee will also be waived for the award recipient.

### Practice Award

- This award is granted by AAMFT and honors members who make significant contributions in terms of access for marriage and family therapists within the healthcare delivery system, including third party payment and both private sector and insurance (including managed care) industries. The award consists of a plaque presented at our Annual Conference. The conference registration fee will also be waived for the award recipient.

## AAMFT Research & Education Foundation Awards

### Organizational Contribution

- Since 1991, the AAMFT Research and Education Foundation has honored up to three members each year for distinctive organizational contributions to the Association. The award consists of a plaque, up to \$1,000 per recipient for travel reimbursement to the Annual Conference, and the conference registration fee will be waived. The AAMFT Foundation will reimburse up to the total of \$1,000 for economy class airfare, transportation to/from airport/hotel, meals per AAMFT allowances for the one day of the ceremony, and one night's hotel stay at one of the AAMFT conference hotels (at the special discounted rate) for the night of the ceremony. You must submit itemized receipts upon your return from the conference. Alcohol will not be reimbursed.

Nominees must be an AAMFT member for at least five years and show significant leadership in two of the following criteria:

1. As an association officer;
2. As an AAMFT Board, committee, or commission member, or former division leader;
3. By achieving passage of federal policies and programs which promote marriage and family therapists;
4. By promoting marriage and family therapy on a national level;
5. By promoting family well-being through public policies. Nominators must submit a curriculum vita of the person being nominated and a written statement of ways that the nominee demonstrates distinctive organizational contributions.

### Outstanding Research Publication Award

- The AAMFT Research and Education Foundation annually confers up to two awards to recognize a published article, monograph, book chapter or book that represents an outstanding scholarly achievement in family therapy research. Outstanding scholarly achievement is construed broadly to include a variety of methods and inquiry (quantitative, qualitative, or conceptual), and a variety of findings, including those that confirm previous work, challenge previous work, or generate new areas of inquiry.



Distinguished Leadership Award

- Since 1983, the AAMFT Research and Education Foundation has recognized persons who have provided outstanding contributions in promoting the development of the practice and the profession of marriage and family therapy within specific areas.

Known as "Mr. Truth in Savings," Dr. Morse established the Consumer Movement Archives (CMA) at Kansas State University Libraries. CMA is the premiere research collection documenting consumer advocacy in the United States. The award is generously funded by the Morse Consumer Movement Archives Endowment through the Kansas State University Foundation.

Robert O. Herrmann Outstanding Dissertation Award

Richard L. D. Morse Applied Consumer Economics Award - Professional Paper

Competitive papers for the Morse ACE Award must have three components: (1) identification of an important consumer problem or issue, (2) articulation of practical solutions to the problem, and (3) strong, convincing communication of the implications of the findings that have immediate usefulness to consumers, consumer professionals, or policy makers. This award honors the legacy of Richard L. D. Morse, a prominent leader in the consumer movement and Kansas State University professor. Known as "Mr. Truth in Savings," Dr. Morse established the Consumer Movement Archives (CMA) at Kansas State University Libraries. CMA is the premiere research collection documenting consumer advocacy in the United States. The award is generously funded by the Morse Consumer Movement Archives Endowment through the Kansas State University Foundation.

It should offer, based on research findings, timely and relevant policy recommendations that are valuable to academicians, policymakers, and financial services professionals as well as advance the knowledge base in aging research in a manner that promotes a constructive image of older persons.

The paper will be a well-written scholarly paper which focuses on important financial planning issues, broadly defined to include the various areas of personal financial planning and consumer issues related to financial planning, and presents information or ideas which are useful for consumers as well as for financial planning professionals, and policymakers.

- The National Endowment for Financial Education (NEFE) is the leading private nonprofit 501(c)(3) national foundation dedicated to inspiring empowered financial decision making for individuals and families through every stage of life. With more than a quarter-century of dedication to the public good, NEFE continues its legacy of service with commitment to providing financial education and practical information to people at all financial levels, including:

- Youth and adult financial education resources,
- Training tools from the classroom to the workplace, and
- Research and consumer surveys

The amount of the Award is \$500 and a recognition plaque. The Awardee and ACCI will be featured in the NEFE digest publication, distributed to a mailing list of about 6,000, including many extension agents.

The content focus of the paper is financial education and the criteria by which the paper will be evaluated will demonstrate that the paper:

- Makes a contribution to the scientific knowledge of financial education, financial behavior, or financial capability;
- Utilizes rigorous methodology as recognized by peers and the discipline;
- Is theoretically grounded;
- Addresses a research gap in the discipline; and

- Is an original manuscript not under review by another publication or group while being considered by ACCI.

#### Carl J. Wiggers Award

- In honor of the Cardiovascular Section's founder, Carl J. Wiggers, whose research defined fundamental pressure-flow relationships in the cardiovascular system. In addition to publishing definitive texts in circulatory physiology, Dr. Wiggers founded Circulation Research and trained numerous future department heads as well as several presidents of the APS. The Wiggers award is presented to a scientist who is a Fellow of the Cardiovascular Section of the APS, who has made outstanding contributions to cardiovascular research throughout their career, has been an active and committed member of the section, and who will attract outstanding new members to the Cardiovascular Section from the United States and abroad.

#### Robert M. Berne Distinguished Lectureship

- In honor of one of the most distinguished members of the Cardiovascular Section, Robert M. Berne, whose research focused on the local chemical regulation of tissue blood flow, with an emphasis on understanding the role of adenosine and how it elicits vasodilation. This award is presented to an emerging leader in cardiovascular research whose current research is particularly stimulating, such that the presentation of this work would contribute to interest in, and growth of, the Cardiovascular Section. The applicant need not be a current member or fellow of the CV Section but should be in a peak career stage of research innovation and productivity.

#### Clinical Science Young Investigator Award

- Sponsored by Portland press. This award recognizes an outstanding junior investigator involved in cardiovascular research, with a focus on translational science and medicine (linking basic science to disease mechanisms). To be eligible, the investigator must have earned an MD, PhD, or equivalent degree within the past 5 years, be an APS member in good standing with a primary affiliation in the Cardiovascular Section, and have submitted a first-authored abstract to the Experimental Biology Meeting. It is expected that the awardee will attend the 2018 Experimental Biology meeting and present his or her research.

#### New Investigator Award

- Founded by the APS in 2002 and is made possible by the generous support of APS Strategic Partner, ADInstruments. This award recognizes outstanding investigators in the early stages of their career who have made meritorious contributions to the scientific areas represented by the Cardiovascular Section of the APS. Candidates must be an APS member in good standing with a primary affiliation in the Cardiovascular Section and should not be above the rank of Assistant Professor or a comparable position in a research track at an academic Institution or in industry.

#### Outstanding Trainee Awards

- The Cardiovascular Section Outstanding Postdoctoral Trainee Award was founded by the APS in 2017 and is made possible by the generous support of APS Strategic Partner, ADInstruments. The award recognizes outstanding postdoctoral trainees who are on a trajectory to make meritorious contributions to the scientific areas represented by the Cardiovascular Section of the APS. Candidates must be an APS member in good standing with a primary affiliation in the Cardiovascular Section and should be classified as a post-doctoral fellow (or equivalent) within an academic institution or in industry.

#### Research Recognition Awards

- Designed to encourage submission of abstracts to the Experimental Biology meetings from junior investigators (i.e., doctoral students and postdoctoral fellows) and are made possible, in part, by the generous support of Data Sciences International (DSI). To be eligible, doctoral students must be engaged in their dissertation research while postdoctoral fellows must have earned an MD, PhD or equivalent degree within the past 5 years. Applicants must be an APS member in good standing with a primary affiliation in the Cardiovascular Section and have submitted a first-authored abstract to the Experimental Biology Meeting.

#### Gabor Kaley Lectureship Award

- A joint initiative of the Microcirculatory Society (MCS) and the Cardiovascular Section (CVS) of the American Physiological Society (APS). The Gabor Kaley Memorial Lectureship Award recognizes an outstanding contributor to the field of microcirculatory physiology/pathophysiology, who is noted for the quality of

his/her research and who has demonstrated commitment to the development and training of junior scientists.

- (\$1,000 plus reimbursement of the advance Experimental Biology meeting registration fee) recognizing an outstanding investigator in the early stages of his/her career. Candidates should be investigators who have made meritorious contributions to the area represented by the Cell Section. They should not be above the rank of Assistant Professor or a comparable position in a research track at an academic institution or in industry (e.g. Scientist, Sr. Scientist, Research Investigator, etc.). They should receive nominations from at least two regular members of the APS. Candidates will be judged on their publications, how the publications relate to the Cell Section, and evidence for independence and promise (grant funding, peer review activities, etc.). Although this is not an abstract-based award, eligibility requires that awardees submit an abstract under a Cell Section Topic Category, attend the EB Meeting, and make an oral or poster presentation. Unlike the other Cell Section awards, they need not be first author of the submission, but are anticipated to be senior author. The candidate must be an APS member in good standing and have primary affiliation with the Cell Section.

#### FIVE Postdoctoral Research Recognition Awards

- (\$500 plus reimbursement of the Experimental Biology meeting advance registration fee) to candidates for work performed while in their first through fifth postdoctoral year or medical residency. Candidates must be first author on an abstract submitted under a Cell Section Topic Category, attend the EB meeting, and participate in a special poster presentation. Abstracts must be submitted by the EB abstract submission deadline, and then all additional application materials must be completed online by December 31 of the same year. The trainee or his/her direct mentor must be a member in good standing of the APS and have primary affiliation with the Cell Section. Members of the Cell Section Steering Committee will evaluate all submitted abstracts and supporting documents and select semi-finalists to make a special poster presentation at the EB meeting. All semi-finalists will be contacted via email and acknowledged in a pre-EB newsletter to the Section membership. Poster judging typically occurs at the beginning of the EB meeting, and awardees will be recognized at the Cell Section dinner at the EB meeting.

#### SIX Robert Gunn Student Awards

- (\$500 plus reimbursement of the advance Experimental Biology meeting registration fee) to medical, graduate (doctoral or masters), or undergraduate students. Candidates must be first author on an abstract submitted under a Cell Section Topic Category, attend the EB meeting, and

participate in a special poster presentation. The trainee or his/her direct mentor must be a member in good standing of the APS and have primary affiliation with the Cell Section. Members of the Cell Section Steering Committee will evaluate all submitted abstracts and supporting documents and select semi-finalists to make a special poster presentation at the EB meeting. All semi-finalists will be contacted via email and acknowledged in a pre-EB newsletter to the Section membership. Poster judging typically occurs at the beginning of the EB meeting, and awardees will be recognized at the Cell Section dinner at the EB meeting.

#### Trainee International Travel Award

- (\$750 plus reimbursement of the advance meeting registration fee) to be given for work done while enrolled as a medical, post-doctoral fellow, graduate (doctoral or masters), or undergraduate student to offset travel expenses to attend an international scientific meeting selected by the Cell Section Steering Committee on an annual basis. Trainees must be first author and present the submitted abstract (poster or presentation) at the meeting. The abstract and all additional application materials must be submitted by the specific meetings application deadline. A Trainee or his/her direct mentor must be a member in good standing of the APS and have primary affiliation with the Cell Section. Members of the Cell Section Steering Committee will evaluate abstracts and supporting information to determine the most meritorious candidate. Please note that acceptance of any other APS travel award to the specified international meeting disqualifies the candidate from receiving the Cell Section Trainee International Travel award. Only one application per candidate will be accepted for any specific year.

#### New Investigator Award

- (\$1,000 plus reimbursement of the advance registration fee at the Experimental Biology Meeting) recognizes an outstanding investigator in the early stages of his/her career. Candidates should be investigators who have made meritorious contributions to the area represented by the CNS Section. They should not be above the rank of Assistant Professor or a comparable position in a research track at an academic institution or in industry (e.g. Scientist, Sr. Scientist, Research Investigator, etc.). They should receive nominations from two regular members of the APS. Candidates will be judged on their publications, how the publications relate to the CNS Section and evidence for independence and promise (grant funding, peer review activities, contributions to the discipline, etc.). The candidate must be an APS member in good standing with affiliation in the Central Nervous System Section. Preference will be given to those with a primary affiliation in the Central Nervous System Section. Although this is not an abstract-based award, awardees must attend the Experimental Biology meeting and make an oral or poster presentation. While there is no limit on the number of times an applicant



may apply for the CNS section New Investigator Award, each applicant is eligible to win this award only once.

Research Recognition Award

- (\$500 plus reimbursement of the advance registration fee) recognizes meritorious research by young investigators, who participate in the Experimental Biology meeting. To qualify for this award, the applicant must have received a Ph.D. or other professional degree within the past 10 years and hold a post-doctoral or junior faculty position. Candidates must be first author on an abstract that is presented as a poster or give an invited talk at the Experimental Biology meeting. The poster or oral presentation should be on a topic related to the central or peripheral nervous system. While there is no limit on the number of times an applicant may apply for a CNS section Research Recognition Award, each applicant is eligible to win this award only once.

Van Harreveld Memorial Award

- (\$500 plus reimbursement of the advance registration fee) recognizes outstanding research in neuroscience by a graduate student, who participates in the Experimental Biology Meeting. The recipient must be first author on an abstract presented at the Experimental Biology meeting. The subject matter of the abstract should be any topic related to the central or peripheral nervous system. While there is no limit on the number of times an applicant may apply for the Van Harreveld Memorial Award, each applicant is eligible to win this award only once.

Joseph Erlanger Distinguished Lectureship of the APS Central Nervous System

- The 12 Distinguished Lectureship Awards are named after outstanding contributors to the disciplinary areas of physiology represented by the 12 APS Sections. The recipient is chosen by the Section as a representative of the best within the discipline. Lecturers present and are active participants at the Experimental Biology meeting. Each year, four of the 12 lecturers give plenary lectures that incorporate the main meeting topic. In the years that sections do not have plenary lectures, the lecturer presents one hour of a featured topic programmed by the section. Each recipient receives a \$1,000 honorarium and up to \$2,000 to cover travel and per diem expenses incurred during the meeting.

August Krogh Distinguished Lectureship

- Sponsored by Novo Nordisk Foundation (\$1,000 plus up to \$2,000 travel reimbursement to the Experimental Biology meeting, complimentary registration to the meeting, and a complimentary ticket to the CEPS Dinner at the EB meeting) is awarded to a distinguished scientist who has made major and meritorious contributions to the scientific areas represented by the APS

Comparative and Evolutionary Physiology Section. It is the most prestigious award of the section. The awardee will deliver an honorary award lecture at the EB Meeting and will be recognized at the Comparative and Evolutionary Physiology Section Dinner and Business Meeting at the EB Meeting. The awardee will also be invited to contribute a review manuscript based upon the lecture for publication in the American Journal of Physiology: Regulatory, Integrative and Comparative Physiology. Members of the section choose the recipient of this award from the slate of nominations selected by the CEPS Steering Committee.

#### New Investigator Award

- (\$1,000 plus reimbursement of the advance registration fee) recognizes an outstanding investigator in the early stages of his/her career. Candidates should be investigators who have made meritorious contributions to the scientific areas represented by the Comparative and Evolutionary Physiology Section. They should not be above the rank of Assistant Professor or a comparable position in a research track at an academic institution or in industry (e.g. Scientist, Sr. Scientist, Research Investigator, etc.). They should receive nominations from at least one regular member of the APS. Candidates will be judged on their publications, how the publications relate to the Comparative and Evolutionary Physiology Section and evidence for independence and promise (grant funding, peer review activities, etc.). Although this is not an abstract-based award, awardees are required to attend the EB meeting in order to receive the cash award.

#### Research Recognition Award

- (\$500 plus reimbursement of the advance registration fee) will provide up to three travel awards in recognition of meritorious research by young investigators who participate in the EB Meeting. Candidates must have completed their Ph.D. within the past 10 years, be a member of APS, and must present a talk or poster at the 2019 EB Meeting. The subject matter can be any topic that deals with comparative and evolutionary physiology.

#### Scholander Award

- (\$500, one year complimentary membership in APS, reimbursement of advance registration fee), and a copy of the Per Scholander Biography *Enjoying a Life in Science*, Univ. of Alaska Press, 1990) will be presented to an outstanding young investigator presenting a paper in the "Scholander Award" Session at the Experimental Biology 2019 meeting. Applicants will be judged during a poster presentation at the meeting.

#### Travel Award

Candidates should be investigators who have made meritorious contributions to the area represented by the Endocrinology & Metabolism Section. They should not be above the rank of Assistant Professor or a comparable position in a research track at an academic institution or in industry (e.g. Scientist, Sr. Scientist, Research Investigator, etc.) and must be within 10 years of their terminal degree (Ph.D. M.D., D.V.M., etc). They should receive nominations from at least two regular members of the APS. Candidates will be judged on their publications, how the publications relate to the Endocrinology & Metabolism Section and evidence for independence and promise (grant funding, peer review activities, etc.). Although this is not an abstract-based award, awardees are expected to attend EB and make an oral or poster presentation. Also, the recipient is expected to submit a brief review article in her/his area of research interest to the *American Journal of Physiology-Endocrinology and Metabolism* for publication within one year of receiving the award. The candidate must be an APS member in good standing with a primary affiliation in the Endocrinology and Metabolism Section.

#### Research Recognition Award

- (\$500 plus reimbursement of the advance registration fee) is presented to up to four graduate students or research fellows whose investigations in endocrinology and metabolism physiology have been designated by the Steering Committee as being examples of meritorious research. Candidates must be first author on a submitted abstract to an APS Endocrinology & Metabolism Section topic category [tbd] and be certified by his/her advisor as being eligible for such an award. Previous Research Recognition Awardees are ineligible to apply.

#### Mead Johnson Research Award

- (\$500 plus reimbursement of the advance registration fee) is intended to recognize the graduate student, resident or postdoctoral fellow who presents the best abstract for research in the area of Endocrinology and Metabolism at the Experimental Biology Meeting. Applicants must upload a copy of the first-authored abstract submitted to an Endocrinology and Metabolism Section topic category [tbd] and a recommendation letter from the sponsor certifying the training status of the applicant.

#### Virendra B. Mahesh Award of Excellence in Endocrinology

- (\$1,000 plus reimbursement of the advance registration fee) is to promote the career development of young investigators pursuing research in the area of Endocrinology. The award will be presented to the graduate student or postdoctoral fellow submitting the best abstract to the Experimental Biology meeting in the area of Endocrinology and Metabolism. The recipient must be first author on an abstract submitted to the Endocrinology & Metabolism Section topic category [tbd] and be certified by his/her advisor as being eligible for such an award. The recipient will be notified prior to the meeting and award presented at the Endocrinology & Metabolism Section Business Meeting and Awards Reception at EB 2018. Previous Mahesh Awardees are ineligible to apply.

#### Solomon A. Berson Distinguished Lectureship

- The 12 Distinguished Lectureship Awards are named after outstanding contributors to the disciplinary areas of physiology represented by the 12 APS Sections. The recipient of the Berson award is chosen by the Endocrinology and Metabolism Section as a representative of the best within that discipline. The Berson lecturer presents a one hour lecture on a topic of their choice. Each recipient receives a \$1,000 honorarium and up to \$2,000 to cover travel and per diem expenses incurred during the meeting. Berson awardees are also expected to attend and participate in the Endocrinology and Metabolism awards meeting which is held on the evening of the day of the Berson Lecture. Individuals may be nominated for the Berson Distinguished Lectureship by APS members in good standing with a primary affiliation in the Endocrinology and Metabolism Section. Self-nominations will not be accepted.

#### Campbell Awards in Endocrinology & Metabolism

- (\$500 plus reimbursement of the advance registration fee) is a poster-based competition that will be held in conjunction with the annual Endocrinology and Metabolism Section Business Meeting at Experimental Biology. The awards will recognize the graduate student, resident or postdoctoral fellow who presents the best poster for research in the area of Endocrinology and Metabolism at the Experimental Biology Meeting. Candidates must be first author on a submitted abstract to an APS Endocrinology & Metabolism Section topic category [tbd] and be certified by his/her advisor as being eligible for such an award. New Investigator Award

#### Impact Award

- Recognizes a mid-career primary EEP member who has either established a line of impactful research or has made a seminal discovery in the areas of environmental, exercise, thermal, or applied physiology. For the purposes of this award, mid-career candidates will be defined as individuals, at the time of application, who are Associate Professors or Full Professors within 10 years of their appointment as an Associate Professor (or a comparable position in a research track at an academic institution or in industry).

#### Edward F. Adolph Distinguished Lectureship

- Recognizes an eminent research scholar who has made meritorious contributions to the areas of environmental, exercise, thermal, or applied physiology and is an outstanding public speaker.

#### Honor Award

- Recognizes a previous or current primary member of the EEP Section who is 60 years of age or older and has made significant research contributions to the scientific advancement of environmental, exercise, thermal, or applied physiology while making significant contributions to enhancing the objectives of the Section.

#### Horace W. Davenport Distinguished Lectureship

- (\$1,000, reimbursement of the EB advance registration fee plus up to \$2,000 travel reimbursement to EB and complimentary admission to the section Banquet at EB) is in honor of one of the most distinguished members of the Gastrointestinal & Liver Physiology Section and past president of the APS, Horace W. Davenport. This is the most prestigious award of the APS Gastrointestinal & Liver Physiology Section. The award recognizes distinguished lifetime achievement in gastrointestinal and liver physiological research, including accomplishments in research, teaching, training and activities within the APS. The ideal candidate will have made contributions whose implications extend beyond the boundaries of gastrointestinal and liver research interests. The

Gastrointestinal & Liver Physiology Section Steering Committee chooses the recipient of this award. Awardees will deliver an honorary award lecture at EB 2020 and are recognized at the Gastrointestinal & Liver Physiology Section Banquet and Business Meeting. Nominators must upload the candidate's curriculum vitae and a nomination letter summarizing the candidate's qualifications.

#### New Investigator Award

- (\$1,000 monetary award, reimbursement of the EB advance registration fee, complimentary admission to the GI & Liver Section Banquet at EB) recognizes an outstanding investigator in the early stages of his/her career. Candidates should be investigators who have made meritorious contributions to the area represented by the Gastrointestinal & Liver Physiology Section. They should not be above the rank of Assistant Professor or a comparable position in a research track at an academic institution or in industry (e.g. Scientist, Sr. Scientist, Research Investigator, etc.). They should receive nominations from at least two regular members of the APS. Candidates will be judged on their publications, how the publications relate to the Gastrointestinal & Liver Physiology Section and evidence for independence and promise (grant funding, peer review activities, etc.). Although this is not an abstract-based award, awardees are expected to attend EB 2019 and make an oral presentation.

#### Takeda Distinguished Research Award

- Recognizes an outstanding investigator who is internationally recognized for his/her contribution to research in areas represented by the Section. The chosen individual will receive a \$1,500 honorarium, reimbursement of the EB advance registration fee and complimentary admission to the GI & Liver Section Banquet at EB. Candidates are judged based on their publication record, and the content of the nomination letter. Qualified researchers can be nominated by regular APS members or can self-nominate. Awardees are recognized at the Gastrointestinal & Liver Physiology Section Banquet at EB 2020, where they are expected to give an after dinner talk, and at the section Business Meeting.

#### Distinguished Research Awards

- Designed to recognize trainees and junior level faculty who are engaged in gastrointestinal and liver research. These awards include a monetary honorarium, reimbursement of the EB advance registration fee and complimentary admission to the GI & Liver Section Banquet at EB2019. The awards are given based on competitive appraisal of abstracts submitted to the Experimental Biology meeting. Separate awards will recognize 1) work done while enrolled as an undergraduate, 2) doctoral/medical student, 3) during the first five years of postdoctoral or medical residency training and 4) done as a junior level faculty who is within 10 years of having received a higher degree (Ph.D., M.D., or D.V.M). The final distribution among these awards will depend on the quality and the number of applicants. Awardees are notified of winning the competition in advance of EB.



### Postdoctoral Poster Awards

- (monetary honorarium; reimbursement of registration fee and complimentary admission to GI & Liver banquet) are designed to recognize a postdoctoral trainee who are engaged in gastrointestinal and liver research. The awards are given based on a poster competition at the Gastrointestinal and Liver Section Trainee Poster Symposium. This presentation is required in addition to the regular EB poster presentation to be considered for this award. The final decision of awards will be based on the quality of research and the oral presentation of the poster by the applicant to the judges at the Trainee Symposium (including the ability to answer questions regarding the presented research). Applicants who have already won a Research Recognition or Takeda Research Award in the EB2019 competition will not be eligible for the Poster Award in the same year. Awardees will be recognized at the EB2019 Gastrointestinal & Liver Physiology Section Banquet and Business Meeting.

### The Carl Ludwig Lectureship Award

- One of 12 APS distinguished lectureship awards named after outstanding contributors to different areas of physiology as represented by the 12 APS sections. This award honors the achievements of Carl Ludwig, a prominent professor of physiology in the mid and late 1800s. There is scarcely any branch of physiology to which Ludwig did not make important contributions, but he is honored here for his interests and important advancements he made in the function of secretory neurons and the discovery of spinally projecting 'vasomotor' neurons in the medulla, giving birth to the concept of control of cardiovascular and other autonomic functions through neural and neural-secretory reflexes. Above all, Dr. Ludwig placed an important emphasis on the training of future physiologists, and as such, he helped launch the careers of several eminent physiologists including Adolf Fick, Otto Frank, and Henry Bowditch. The Carl Ludwig Award honors a world-renowned, distinguished investigator who has made major contributions toward a better understanding of some aspect of autonomic regulation in normal and/or disease states. It is the most prestigious award offered by the Neural Control and Autonomic Regulation (NCAR) section of APS. The recipient is chosen by the NCAR section steering committee as a representative of the best within this discipline who is actively involved in innovative and productive research. The recipient's body of research should be particularly stimulating, such that the presentation of this work would contribute to interest in, and growth of, the NCAR section and research in the field. The applicant need not be a current member of the NCAR Section or APS, but contributions to the advancement of the autonomic field in all aspects of the discipline are considered in the selection process (research impact, participation in APS or other autonomic-related societies, dissemination of knowledge through

writings and conferences, mentoring of investigators within the autonomic community, and other related activities). The awardee will present a 45 minute lecture with discussion, chair a minisymposium immediately following the lecture on a topic related to his/her lecture, and actively participate in NCAR functions at the Experimental Biology meeting. He or she will receive a \$1,000 honorarium and up to \$2,000 to cover travel and per diem expenses incurred during the meeting. Prior recipients of the award are not eligible for re-nomination, but prior unsuccessful nominations are welcome and encouraged for resubmission.

#### Michael J. Brody Young Investigator Award

- Made possible by APS Strategic Partner, ADInstruments (\$500 plus reimbursement of the advance registration fee) recognizes a promising young investigator who has made a significant research contribution to the understanding of neural control and autonomic regulation. The award is open to graduate students (post-candidacy exams) and to postdoctoral and clinical fellows or equivalent (within 3 years from degree [month/year] to the date of award application deadline). The applicant must be an APS member in good standing with a primary affiliation in the NCAR Section.

#### New Investigator Award

- (\$1,000 plus reimbursement of the advance registration fee), made possible by APS Strategic Partner, ADInstruments, recognizes an outstanding investigator in the early stages of his/her independent career. Candidates should be investigators who have made meritorious contributions to the area represented by the NCAR Section. They should not be above the rank of Assistant Professor or a comparable position in a research track at an academic institution or in industry (e.g. Scientist, Research Investigator, etc.). Eligible candidates must not have held the rank of Assistant Professor or equivalent for more than 3 years [month/year] from the date of award application deadline. Applicants also must not have held an advanced degree (PhD, MD, DVM or equivalent) for more than 8 years [month/year] from the date of award application deadline. The applicant must be an APS member in good standing with a primary affiliation in the NCAR Section

#### Research Recognition Awards

- (\$500 plus reimbursement of the advance registration fee) provide travel support to 1 graduate student, 2 postdoctoral research fellows and 1 early career investigator to present meritorious research at the annual Experimental Biology Meeting. Eligibility for the candidates is as follows: the graduate student must have completed post candidacy exams, as certified in the advisor/chair letter; the postdoctoral or clinical fellows must be within 5 years of degree [month/year] by the date of award reception and the early career investigator must have completed postdoctoral training with an academic rank not higher than that of Assistant Professor and be within 2 years of appointment [month/year] by the date of award reception. Research focus should be in the area of neural control and autonomic regulation. Applicants must be APS members in good standing with primary affiliation to the NCAR Section.

### Experimental Biology Trainee Award

- Donations collected from the NCAR membership and corporate sponsors have allowed for the creation of this new award that will be given for the first time during Experimental Biology 2017. This award provides travel support to a graduate student or postdoctoral research fellow to present meritorious research at the annual Experimental Biology Meeting. Award winner will be selected from the applications received for the Research Recognition Award, therefore there is no need to fill a separate application. Eligibility and selection criteria are the same as for the Research Recognition award, except this award is not open to early career applicants.

### The NCARNation Trainee Presentation Award

- Starting in 2014, a member of NCAR committed to anonymously sponsor a trainee award for a period of 10 years with the requirement that NCAR trainees would be given the opportunity to make an oral presentation at the Experimental Biology meeting to showcase their research. As of 2017, another NCAR member will match the donation to allow for a second award to be given to a postdoctoral trainee. The NCARNation session provides 12 selected trainees with an opportunity to give a brief oral presentation (5 min) during the Experimental Biology meeting. Abstracts are selected among all the abstracts submitted by NCAR trainees to an NCAR topic by a committee composed of the NCAR trainee representative and former NCARNation participants. During the oral presentation, the judges (members of the NCAR steering committee) rank the speakers based on the following criteria: significance, innovation, clarity of the presentation, familiarity with the field, ability to answer questions. The best presentations by a graduate student and a postdoctoral fellow are presented with the NCARNation award (\$250).

### Postdoctoral Excellence in Research Awards

- Recognize postdoctoral fellows who are first author on an abstract presented at the Experimental Biology 2018 meeting involving renal-based research. Applicants may not have won this award in previous years. Applicants must submit and upload a copy of a first authored EB2019 abstract to be considered for this award. Finalists will be notified prior to the EB meeting and will be judged by the Renal Section Awards Committee during the Renal Section's Posters and Professors Reception at the meeting. Awardees are recognized at the 2018 Renal Dinner. Each awardee will be invited to submit a mini-review for AJP-Renal Physiology with the senior author on their EB2019 abstract. Mini-reviews are to be on a topic related to their abstract, with fewer than 1500 words and no more than 1 figure.

### Research Recognition Awards

- (\$500 plus reimbursement of the advance registration fee) recognize the meritorious research by young investigators (junior faculty) who participate in the Experimental Biology Meeting (up to four awards are given). Applicants should not be above the rank of Assistant Professor or a comparable position in a research track at an academic institution or in industry (e.g. Scientist, Sr. Scientist, Research Investigator, etc.), and may not have won this award in previous years. Applicants cannot apply for a Postdoctoral Excellence in Research Award in the same round of applications. Candidates must be an author on an abstract presented at the EB2018 meeting involving renal-based research. Membership in the APS is not required, but awardees will be encouraged to join if they are not members. Applicants must upload a copy of the submitted abstract(s) and the candidate's CV. Awardee's will be invited and encouraged to write a mini-review for Am J Physiol: Renal Physiol on a topic related to their submitted abstract. These reviews will be no longer than 1500 words and are not to have more than 1 figure. Awardees must attend the Experimental Biology meeting in order to collect the cash prize and are recognized at the EB 2019 Renal Dinner.

### New Investigator Award

- (\$1,000 honorarium and reimbursement of the advance registration fee) recognizes an outstanding investigator in the early stages of his/her career. Candidates should be investigators who have made meritorious contributions to the areas of research represented by the Renal Section. They should not be above the rank of Assistant Professor or a comparable position in a research track at an academic institution or in industry (e.g. Scientist, Sr. Scientist, Research Investigator, etc.). They should receive nominations from at least two regular members of the APS. Candidates will be judged on their publications, how the publications relate to the Renal Section and evidence for independence and promise (grant funding, peer review activities, etc.). Although this is not an abstract-based award, awardees are expected to attend the EB meeting and make an oral or poster presentation. The candidate must be an APS member in good standing with a primary affiliation to the Renal Section to be considered for this award. The awardee will be invited and strongly encouraged to write a Review which will be published in Am J Physiol: Renal Physiol. Candidates must upload: curriculum vitae, 2 nomination letters from APS members, and 3 reprints. Awardees must attend the Experimental Biology meeting in order to collect the cash prize and are recognized at the EB 2019 Renal Dinner.

### Young Investigator Award

- (\$1000 honorarium, reimbursement for up to \$1500 in travel expense reimbursement, reimbursement of the annual meeting advance registration fee, plus a complimentary ticket to the Renal Dinner) recognizes an outstanding young investigator pursuing research in renal physiology, pathophysiology or hypertension. Candidates must be less than 41 years of age or less than 15 years beyond earning their first doctoral degree, and must have published original work

in Am J Physiol: Renal Physiol during the preceding years. Candidates will be judged on their nomination letters, publications, service to the research community, and funding record. The recipient will present the Young Investigator Award Lecture, organize/chair a featured topic session, participate in the Renal Section's Posters and Professors Reception, and be recognized at the Renal Dinner during EB 2020. The awardee will be invited and strongly encouraged to write a Review which will be published in Am J Physiol: Renal Physiol. Nominators must upload a nomination letter and a seconding letter (optional). A copy of the nominee's CV must also be uploaded. Applicants must have a primary affiliation to the Renal Section to be considered for this award.

Carl W. Gottschalk Distinguished Lectureship of the APS Renal Section

- (\$1000 honorarium, reimbursement for up to \$2000 in travel expenses, complimentary registration, plus a complimentary ticket to the Renal Dinner) recognizes a world-renown, distinguished scientist who has made major contributions to understanding physiological processes through state-of-the-art research, and who is an engaging speaker. The candidate's area(s) of research expertise need not be in renal physiology, but should be of interest to Renal Section members. In addition to delivering the Carl W. Gottschalk Distinguished Lecture, the recipient will participate in the Renal Section's Posters and Professors Reception and will be recognized at the Renal Dinner held during EB 2020. The awardee will be invited and strongly encouraged to write a Review which will be published in Am J Physiol: Renal Physiol. Nominators must upload no more than 2 pages summary of the candidate's contributions relevant to renal physiology.

Robert W. Berliner Award for Excellence in Renal Physiology

- (\$1000 honorarium, reimbursement for up to \$2000 in travel expenses, complimentary registration, plus a complimentary ticket to the Renal Dinner) is the most prestigious award of the APS Renal Section. The award recognizes distinguished lifetime achievement in renal physiological research by a living scientist. Candidates must be at least 60 years of age, and must have been a major contributor to the field of renal physiology over a lifetime, including accomplishments in research, teaching, training and activities within the APS. The recipient will be honored at the 2019 Renal Dinner, and will participate in the Renal Section's Posters and Professors Reception at EB2019. The awardee will be invited and strongly encouraged to write a Review which will be published in Am J Physiol: Renal Physiol. Nomination materials consist of the candidate's curriculum vitae and a nomination letter summarizing the candidate's qualifications.

#### New Investigator Award

- (\$1,000 plus reimbursement of the advance registration fee) recognizes an outstanding investigator in the early stages of his/her career. Candidates should be investigators who have made meritorious contributions to the area represented by the Respiration Section. They must not be above the rank of Assistant Professor or a comparable position in a research track at an academic institution or in industry (e.g. Scientist, Sr. Scientist, Research Investigator, etc.). Applicants must have been independent investigators for no more than 8 years at the time of submitting the application. They must receive nominations from at least two regular members of the APS. Candidates will be judged on their publications, how the publications relate to the Respiration Section, evidence for independence and promise (grant funding, peer review activities, etc.) and level of participation in Experimental Biology and APS-related activities. Although this is not an abstract-based award, awardees are expected to attend the Experimental Biology meeting and make an oral or poster presentation. The candidate must be an APS member in good standing with a primary affiliation in the Respiration Section. Candidates must upload: curriculum vitae, 2 nomination letters from APS members, and 3 reprints. Awardees must attend the Experimental Biology meeting in order to collect the cash prize and are recognized at the Respiration Section Banquet.

#### The Respiration Section Outstanding Trainee Award

- (\$1,000 plus reimbursement of the advance registration fee) recognizes an outstanding postdoctoral trainee who submitted their abstract to an APS Respiration Section topic category at the Experimental Biology meeting. Candidates should be young investigators who have made meritorious contributions to the area represented by the Respiration Section. They must receive nominations from at least two regular members of the APS. Candidates will be judged on their publications, how the publications relate to the Respiration Section, evidence for future independence and promise (grant funding, peer review activities, etc.) and level of participation in Experimental Biology and APS-related activities. The candidate must be an APS member in good standing with a primary affiliation in the Respiration Section. Candidates must upload: a copy of their first-authored abstract, curriculum vitae and 2 nomination letters from APS members. Candidates may also upload up to 3 reprints. Awardees must attend the Experimental Biology meeting in order to collect the cash prize and are recognized at the Respiration Section Banquet.

### Research Recognition Awards

- (\$500 plus reimbursement of the advance registration fee) recognize outstanding research by graduate students and postdoctoral fellows who submitted their abstract to an APS Respiration Section topic category at the Experimental Biology meeting. Applicants must upload a copy of their first-authored abstract. Awardees must attend the Experimental Biology meeting in order to collect the cash prize and are recognized at the Respiration Section Banquet.

### Trainee Poster Presentation Awards

- Recognize outstanding research by undergraduate and graduate students and postdoctoral fellows who submitted their abstract to an APS Respiration Section topic category at the Experimental Biology meeting. Trainee presentations are judged at their poster presentation during the Experimental Biology meeting and winners are recognized in the Respiration Section Newsletter. Up to 20 trainees will receive awards of \$100 each. Ten of these awards are sponsored by Data Sciences International (DSI).

### Julius H. Comroe, Jr. Distinguished Lectureship

- The 12 Distinguished Lectureship Awards are named after outstanding contributors to the disciplinary areas of physiology represented by the 12 APS Sections. The recipient is chosen by the Section as a representative of the best within the discipline. Lecturers present and are active participants at the Experimental Biology meeting. Each year, four of the 12 lecturers give plenary lectures that incorporate the main meeting topic. In the years that sections do not have plenary lectures, the lecturer presents one hour of a featured topic programmed by the section. Each recipient receives a \$1,000 honorarium and up to \$2,000 to cover travel and per diem expenses incurred during the meeting.

### The Usha (which means dawn in Sankrit) Awards

- Dr. Prakash YS, Deputy Editor of the American Journal of Physiology-Lung Cellular and Molecular Physiology, is soliciting nominations for the Usha awards. The nominee must be a promising trainee (undergraduate or graduate student, or a research fellow (5 years since being granted the terminal degree (e.g. PhD, MD, DO, DVM), and should have contributed a 1st author abstract to the Respiration Section of the APS for presentation at the APS. Criteria for selection will include the level of excitement regarding the nominee's future, contribution by the nominee to the work, and the importance of the work to the field. Nominees are to be selected by the Respiration Section of the APS. The TWO winners will receive \$500 and a certificate of appreciation at the EB 2019 meeting.

#### Giles F. Filley Memorial Award for Excellence

- Recognizes excellence in respiratory physiology and medicine. The award is given to an investigator who holds an academic rank no higher than assistant professor. The award is presented annually to an individual demonstrating outstanding promise based on his/her research program in respiratory physiology and medicine. Each recipient receives a \$16,000 award designated for use in the research program. The award is announced during the APS Business Meeting held at the Experimental Biology meeting and at the Respiration Section Dinner. The recipient receives complimentary registration to attend the meeting and a certificate recognizing his/her designation as a Giles F. Filley Awardee. The award does not include any indirect cost reimbursement. Applications are accepted from members of APS working within the U.S., reflecting Giles F. Filley's contributions to the national research community through his membership in APS. Because of Giles F. Filley's long association with the University of Colorado, Denver, preference for one award, on a competitive basis, is given to an individual affiliated with that institution. The award does not include any indirect cost reimbursement.

#### Claude Bernard Distinguished Lectureship Award

- Presented to an established investigator with a history of excellence in education who is making outstanding contributions to teaching and learning. This award is made possible by APS Strategic Partner, ADInstruments. Educators from all fields are eligible but must be nominated by an APS member other than the nominee. The awardee's talk is expected to further interest in and enhancement of educational practices that are relevant to teachers of physiology. The award consists of a \$1,000 honorarium, up to \$2,000 travel reimbursement to Experimental Biology, complimentary registration to the meeting, and two complimentary tickets to the Section dinner.

#### Arthur C. Guyton Educator of the Year Award

- (\$1,000 cash prize plus reimbursement of the advanced registration fee, a framed, inscribed certificate, up to \$750 in travel reimbursement to the Experimental Biology meeting and a complimentary ticket to the Section Dinner) recognizes a full-time faculty member of an accredited college or university and member of the APS who has independent evidence of: (1) excellence in classroom teaching over a number of years at the undergraduate, graduate, or professional levels; (2) commitment to the improvement of physiology teaching within the candidate's own institution; and (3) contributions to physiology education at the local community,



national or international levels. The awardee is requested to write an essay on his/her philosophy of education for publication in *The Physiologist*. The typical nominee will have shown excellence in teaching and have made significant contributions in student advisement, graduate education, and/or curriculum design and reform at their institution. The activities that distinguish a candidate in the rankings include outreach activities at the state, national, or international level; contributions to education through APS activities; peer-reviewed educational journal articles; and widely disseminated publications such as commercially produced textbooks, lab manuals, or software. Unsuccessful nominees may be reconsidered for the award during the subsequent year with notification to the nominee and the nominator and receipt of updated information. The award winner is announced at the APS Business Meeting during Experimental Biology.

#### New Investigator Award

- (\$1,000 plus reimbursement of the advanced registration fee and a complimentary ticket to the Section banquet) recognizes an outstanding investigator in the early stages of his/her career. Each candidate should be an investigator who has made meritorious contributions to the area represented by the Teaching of Physiology Section. At the time of the application, he or she should not be above the rank of Assistant Professor or a comparable position in a research track at an academic institution or in industry (e.g. Scientist, Sr. Scientist, Research Investigator, etc.). Although this is not an abstract-based award, the awardee is required to attend EB and make an oral or poster presentation there in order to collect the cash prize. The recipient is also recognized at the Teaching of Physiology Section Business Meeting. To qualify for this award, a candidate must be an APS member in good standing with a primary affiliation in the Teaching of Physiology Section and hold an early-career appointment as described above. Each candidate is required to upload a curriculum vitae, 2 letters of support from other APS members, and 3 reprints of relevant publications. If he or she has one or more abstracts submitted to EB, the candidate is also requested to upload his or her abstract numbers, the full name of each first author, and PDFs of the abstracts to be presented at EB.

#### Research Recognition Awards

-Provides two awards for outstanding posters presented in the Teaching Poster Sessions at Experimental Biology (\$500 plus reimbursement of the advanced registration fee, and a complimentary ticket to the Section banquet). Awardees must attend the Experimental Biology meeting in order to collect their cash prizes. The recipients are also recognized at the Teaching of Physiology Section Business Meeting. To qualify for this award, a candidate must be first author on the poster, and either age 40 or younger OR be within 10 years of receiving his or her Ph.D., M.D., or D.O. All poster abstracts must be formally submitted to EB by the November abstract deadline. Each candidate is required to upload a copy of his or her first-

authored abstract for EB with the Research Recognition Award application. If the candidate is a past winner, the candidate is also required to upload a copy of the abstract from that year.

William Galey Professional Skills Training Scholarship Award

- This award provides funds for graduate students or postdoctoral fellows to attend and participate fully in either the APS Professional Skills Training (PST) Live Course or the APS Institute on Teaching and Learning (ITL). This award is given in memory of William Galey in honor of his commitment to the teaching and professional development of trainees in physiology.

Data Sciences International New Investigator Award

- Recognizes an outstanding investigator in the early stages of his/her career. Candidates should be investigators who have made meritorious contributions to the area represented by the Water and Electrolyte Homeostasis Section. They should not be above the rank of Assistant Professor or a comparable position in a research track at an academic institution or in industry (e.g. Scientist, Sr. Scientist, Research Investigator, etc.). Any member of the APS in good standing with a primary affiliation in the Water and Electrolyte Homeostasis Section may apply or be nominated for the award. Applications are reviewed by the Awards Committee of the Water and Electrolyte Homeostasis Section. Candidates will be judged on their research, how their publications and engagement relate to the Water and Electrolyte Homeostasis Section, evidence for independence and promise (grant funding, peer review activities, etc.), and letters of recommendation. The recipient of the award will present a lecture on his/her research during a WEH sponsored session at the annual Experimental Biology meeting and will be invited to publish a manuscript on this presentation in the *American Journal of Physiology-Regulatory, Integrative & Comparative Physiology*. Awardees must attend the Experimental Biology meeting in order to collect the cash prize and are recognized at the Water and Electrolyte Homeostasis Luncheon and Business Meeting.

Juan Carlos Romero Postdoctoral Research Recognition Award

- To be eligible, the investigator must be a postdoctoral fellow. Applicants must be first author on an abstract submitted to an APS Water & Electrolyte Homeostasis Section sponsored topic category at the EB meeting. The Section Awards Committee will judge the abstracts and name 3 finalists who agree to attend EB and make an oral presentation in a WEH sponsored session. Finalists will receive \$300 and a complimentary ticket to the Water

& Electrolyte Luncheon and Business Meeting. Finalists will be judged on their oral presentation, and the finalist with the top combined score from the abstract and oral presentation will receive the Juan Carlos Romero Research Recognition Award (an additional \$300) and be invited to submit a Featured Topic for the following EB meeting under the direction of a steering committee member or the recipient of the Water and Electrolyte Homeostasis New Investigator Award. Finalists will be recognized and the awardee will be announced at the Water and Electrolyte Homeostasis Section Luncheon and Business Meeting at the EB meeting. Finalists must attend the Experimental Biology meeting, give an oral presentation, and must provide a copy of their submitted abstract in order to collect the cash prize. All applications that are not selected for finalists will be considered for the WEH Section / AJP: Regulatory, Integrative, and Comparative Trainee Award, and the WEH Research Distinction Award.

#### Ernest H. Starling Distinguished Lecture

- The 12 APS Distinguished Lectureship Awards are named after outstanding contributors to the disciplinary areas of physiology represented by the 12 APS Sections. The named lecture for the Water & Electrolyte Homeostasis Section is the Ernest H. Starling Distinguished Lectureship. It is the most prestigious of the APS Water and Electrolyte Homeostasis Section awards and is awarded annually to an APS member recognized for exceptional contributions and lifelong dedication to Water and Electrolyte Homeostasis research. The recipient is chosen by the Section as a representative of the best within the discipline. Lecturers present and are active participants at the Experimental Biology meeting. The recipient receives a \$1,000 honorarium and up to \$2,000 to cover travel and per diem expenses incurred during the meeting.

#### Leonard Share Award

- Dr. Leonard Share was responsible for recognizing WEH research as a sub-discipline with the APS, and for the subsequent formation of the WEH section in 1982. The Leonard Share Award was established in 2015 to recognize a WEH member that has contributed their time and talents to our section as well as to APS. The member cannot have served as President of APS, but most likely has served in many other capacities and is one of our "unsung heroes". The Awardee will also have a well-recognized research program that has contributed to the knowledge of WEH research. The Awardee will be announced at the WEH Section Luncheon and Business meeting and will receive \$1000, and a custom-designed WEH section plaque.

The awardee will be invited to present the distinguished lecture at the PG group Symposium at the ensuing Experimental Biology meeting and be asked to submit a topical review to the PG Journal.

### Physiological Genomics Group New Investigator Awards

- With generous support from APS Strategic Partner, ADInstruments (\$500 plus meeting registration) and the Physiological Genomic Journal, recognizes outstanding early career investigator(s). Each year, the PG group invites nominations from young investigators who have made meritorious contributions to the scientific areas represented by the Physiological Genomics group of APS. The objective of the PG Group New Investigator Award is to stimulate innovative research in physiological -omics and to recruit young scientists to the field of physiological genomics. ### Physiological Genomics Trainee Awards

- The Physiological Genomics Interest Group Data Sciences International PG Trainee Research Excellence Award, with generous support from APS Strategic Partner, Data Sciences International (DSI), recognizes outstanding trainees who have the potential to make meritorious contributions to the scientific areas represented by the Physiological Genomics group of APS. Candidates must be an APS member in good standing and member of the PG Interest group and should be classified as a trainee (e.g., high school, undergraduate, graduate, postdoctoral fellow, or equivalent) within an academic institution or industry. Three top prize trainees will receive \$300 (1st place), \$200 (2nd place), or \$100 (3rd place). Research Recognition

Award certificates will be given to trainees who are selected to present their work at the PG group Trainee Highlights Session at EB. Each year, participants are selected for the PG Group Trainee Symposium based on the trainee status and abstract relevance to physiological -omics. Awards are determined based on quality of the abstract, relevance of their research to physiological -omics, and oral presentation at the Experimental Biology meeting PG group Trainee Highlights session.

#### A. Clifford Barger Underrepresented Minority Mentorship Award

- Honors a member of the American Physiological Society who is judged to have demonstrated leadership, guidance, and mentorship of underrepresented minority (URM) students in the physiological sciences. The Barger award promotes and embodies the APS goal of broad diversity among physiologists by recognizing outstanding mentors who make significant impacts on diversity in physiology. It recognizes mentoring as a highly valued professional activity that merits a high level award by the Society. ### The G. Edgar Folk Senior Physiologists Award

Edgar Folk Senior Physiologists Award is presented to senior physiologists, 70 years or older, who no longer have grant funds available to them. The award may be used for purposes such as attending a meeting of the Society to present a paper, engaging in a series of modest experiments, or completing a manuscript. The applicant must be an APS member. The award is given throughout the year with a recipient receiving up to \$500 depending upon the need. The Senior Physiologists Committee assists in the selection of the recipient. The names of recipients are not made public.

### The APS International Opportunity Program (IOP)

- Established in 2013, provides funds to support educational, training, research, or public outreach events outside of the USA, with the following goals: (1) To promote interactions and exchange between APS members, sister societies, and other international physiologists; (2) To foster education, scientific research, and dissemination of information in the physiological sciences; (3) To support underrepresented regions; and (4) To raise the global stature of the APS. Events eligible for IOP support include training workshops, conferences, research symposia (including satellite symposia), and other events promoting physiology education, training, research, or public outreach. The International Physiology Committee of the APS reviews applications by applying the following criteria: (1) Quality of the scientific content; (2) Diversity of invited participants (with respect to gender, country of work, career stage); (3) Clearly articulated plan to involve graduate students and postdoctoral trainees; and (4) Budget justification. Preference is given to events held in, or otherwise serving, underrepresented countries or regions. Stand-alone research symposia programmed for a half day or less are not eligible for support; however, a half-day symposium combined with a laboratory component or other event(s) may be eligible for support. APS makes up to six IOP awards annually, each with a maximum budget of \$7,500.

Orr E. Reynolds Award

- Named for the second Executive Secretary-Treasurer, is presented for the best historical article submitted by a member of the Society. Articles may deal with any aspect of the history of physiology, including the development of physiological ideas and their application, instrumentation, individual and collective biography, departmental and institutional history, history of societies including APS, and physiology in its public context. Manuscripts should represent original research and be adequately documented. Articles published in journals or books of the Society during the prior three calendar years are also eligible for the award upon request by the author. If an author submits a manuscript/article but is not successful in obtaining the award, the same manuscript/article may be submitted for two consecutive years.

The Physiology in Perspective: The Walter B. Cannon Award Lectureship

- Awarded to an outstanding physiological scientist, domestic or foreign, who is an APS member. The recipient is selected by the President-Elect in recognition of his/her original and outstanding accomplishments in the field of physiology. The recipient presents a lecture on "Physiology in Perspective" during the plenary session of the Experimental Biology meeting,

addressing Cannon's concepts of "The Wisdom of the Body." The lecture is considered for publication in the Society journal of their choosing. The recipient receives an honorarium of \$4,000, a plaque, and reimbursement of expenses incurred in association with delivery of the lecture. The membership is invited to submit nominations for this lecture. A nomination shall be accompanied by a candidate's curriculum vitae and one letter detailing the individual's status and contributions. Nominations are only accepted via online submission. The Walter B. Cannon Award Lecture is generously supported by Sucampo AG.

#### Ray G. Daggs Award

- In honor of the Society's first Executive Secretary, is presented to a physiologist who is judged to have provided distinguished long-term service to the science of physiology and, in particular, to the American Physiological Society, by holding a prominent position in the Society. Established in 1973, the Ray G. Daggs Award is presented at the spring Business Meeting of the Society. A Certificate of Citation, expenses to participate in the Experimental Biology meeting, and \$500 are presented to the recipient.

#### APS Research Career Enhancement Award (RCEA)

- Designed to enhance the career potential of regular members of APS who hold the rank equivalent to Assistant Professor or above. The award of up to \$20,000 allows an individual in the early phases of his/her career to obtain special training or an individual in the later phases of his/her career to develop new skills or retrain in areas of developing interest. The award can be used to support visits to other laboratories to acquire specific new skills and/or to support attendance at special courses devoted primarily to methodologies appropriate for either a new investigator or a more senior investigator entering a new field of research. The award does not include any reimbursement for indirect costs.

#### S&R Foundation Ryuji Ueno Award

- Established in 2007 through the generous support of Ryuji Ueno, M.D., Ph.D., Sachiko Kuno, Ph.D., and S&R Foundation. Dr. Ueno and Dr. Kuno are founders of Sucampo Pharmaceuticals, Inc. and S&R Foundation, both in Bethesda, Maryland. The Ryuji Ueno Award is given annually to an individual demonstrating outstanding promise based on his/her research in wound healing, tissue remodeling, organ regeneration, or stem cell biology. Relevant projects can include a range of topics in fundamental research; ranging from exploring the cellular and molecular physiology of these processes to the impact on organism physiology. Applications are accepted from APS members who hold an academic rank of faculty member, no higher than



assistant professor, or a comparable position if the member is not affiliated with an academic institution. The award of \$30,000 is designated for use in the awardee's research program in the area of interest to the S&R Foundation. The award does not include any indirect cost reimbursement. The recipient receives complimentary registration to attend the Experimental Biology Meeting and a certificate presented at the Society's Business Meeting.

#### APS Teaching Career Enhancement Award (TCEA)

- Designed to enhance the career potential of regular members of APS who hold a rank equivalent to Assistant Professor or above. The award of up to \$10,000 allows an individual to develop innovative and potentially widely applicable programs for teaching and learning physiology. The award can be used either to support short-term visits to other schools to consult with experts who can assist with the development project, to pay for attendance at special courses devoted to methodologies appropriate for the educational development project, or research or development collaborations that will result in products or publications. The award does not include any reimbursement of indirect costs.

ADInstruments Macknight Early Career Innovative Educator Award

- made possible by our strategic partner ADInstruments, honors an APS member who demonstrates the greatest potential for incorporating innovative teaching techniques and effectively utilizing technology resources in engaging undergraduate students in physiology education. The awardee receives a \$1,500 honorarium, up to \$2,000 travel reimbursement, and complimentary registration to attend the Experimental Biology meeting, and an institutional grant providing the award recipient's institution with a PowerLab PTB4153 Human and Animal Physiology System or equivalent.

Arthur C. Guyton Award Fund

- Established in 1993 from an anonymous donation in order to recognize the contributions of Arthur C. Guyton and his interests in feedback control and mathematical modeling of physiological systems. The award is intended to support an independent investigator who holds an academic rank no higher than Assistant Professor and is pursuing research that utilizes quantitative and integrative approaches and feedback control system theory for the study of physiological functions. An award of approximately \$30,000 is designated for the use in the awardee's research program. The award does not include any indirect cost reimbursement. One award is given annually to an individual demonstrating outstanding promise based on their research program in feedback control systems, quantitative modeling, and integrative physiology. Applicants must be Regular APS Members. The awardee is selected by members of the APS Awards Committee. The Award recipient receives complimentary registration to attend the Experimental Biology meeting and a certificate presented at the APS Business Meeting held at the Experimental Biology meeting.

#### Beverly Petterson Bishop Award

- Recognizes excellence in neuroscience/neurophysiology research. The award is given to an investigator who holds an academic rank no higher than assistant professor. The award is presented annually to an individual demonstrating outstanding promise based on his/her program in neuroscience/neurophysiology research. Each recipient receives a \$20,000 award designated for use in their research program. The award is announced during the APS Business Meeting held at the Experimental Biology meeting. The recipient receives complimentary registration to attend the meeting and a certificate recognizing his/her designation as a Beverly Peterson Bishop Awardee. Applications are accepted from APS members in good standing who are performing neuroscience research. The selection committee will be comprised of representatives from the Central Nervous System (CNS) and the Neural Control and Autonomic Regulation (NCAR) sections. The award does not include any indirect cost reimbursement.

#### The Dale J. Benos Early Career Professional Service Award

- (\$1,000 + advanced EB registration) honors an early career stage (graduate student, post-doctoral fellow, Assistant Professor or equivalent position) member of the American Physiological Society. The Award will honor someone who is judged to have made outstanding contributions to the physiology community and demonstrated dedication and commitment to furthering the broader goals of the physiology community. This can be by serving on professional committees, participating in K-12 education outreach, participating in scientific advocacy and outreach programs, or by otherwise strengthening and promoting the physiology community.

#### The Dean Franklin Young Investigator Award

- established by Data Sciences International (DSI) in recognition of Franklin's role in the development of instrumentation to monitor physiological function in conscious research animals. Concepts originally formulated by Dean Franklin continue to serve as the inspiration behind many of DSI's most technologically advanced physiological monitoring systems developed for today's nonclinical research. The intent of the award is to recognize a post-doctoral scientist or junior faculty member who is pursuing in vivo physiological research and is in the process of establishing an independent laboratory. The award recipient receives a travel award of \$1,500 to attend the annual Experimental Biology meeting to present their work, and a DSI instrumentation starter kit (approximate value \$20,000). A certificate is presented to the Award recipient at the APS Business Meeting held at the Experimental Biology meeting. The award does not include any indirect cost reimbursement.

The Giles F. Filley Memorial Award for Excellence in Respiratory Physiology and Medicine

- recognizes excellence in respiratory physiology and medicine. The award is given to an investigator who holds an academic rank no higher than assistant professor. The award is presented annually to an individual demonstrating outstanding promise based on his/her research program in respiratory physiology and medicine. Each recipient receives a \$16,000 award designated for use in the research program. The award is announced during the APS Business Meeting held at the Experimental Biology meeting and at the Respiration Section Dinner. The recipient receives complimentary registration to attend the meeting and a certificate recognizing his/her designation as a Giles F. Filley Awardee. The award does not include any indirect cost reimbursement. Applications are accepted from members of APS working within the U.S., reflecting Giles F. Filley's contributions to the national research community through his membership in APS. Because of Giles F. Filley's long association with the University of Colorado, Denver, preference for one award, on a competitive basis, is given to an individual affiliated with that institution. The award does not include any indirect cost reimbursement.

Henry Pickering Bowditch Award Lectureship

- awarded to a regular member, who are 42 years old or less at the time of the Bowditch Lecture, or who are less than eight years from the start of their first faculty or staff research scientist position beyond postdoctoral training, for original and outstanding accomplishments in the field of physiology. Selected by the APS President, the recipient presents a lecture at the Experimental Biology meeting, which is considered for publication in the Society journal of their choosing. The recipient receives an honorarium of \$2,500, reimbursement of expenses incurred while participating in the Experimental Biology meeting, and a plaque. The membership is invited to submit nominations for the Bowditch Lecturer. A nomination shall be accompanied by a candidate's curriculum vitae and one letter detailing the individual's status, contributions, and potential.

International Early Career Physiologist (IECP) Travel Awards

- presented to graduate students, post-doctoral fellows and junior faculty members who work outside the United States. This initiative of the International Physiology Committee is designed to assist with travel expenses that international early career physiologists incur in attending the Experimental Biology Meeting in order to present their work. Up to 12 awards of \$1,000 each will be made annually.

John F. Perkins, Jr. Memorial Award

- promotes cultural exchange and scientific collaborations by providing supplementary aid to families of foreign scientists working for a minimum of

3 months in the U.S. In this way, young scientists are able to bring their spouse and children and thus make full use of the cultural exchange as well as the scientific benefits associated with an international collaboration. This award is intended to support family visits to the US for postdoctoral fellows and junior faculty from overseas. The program presupposes that the visiting scientist and his/her host already have made arrangements for scientific collaboration and have sufficient funds to cover the needs of the visiting scientist. Several awards are granted each year. Application for the Perkins Award must be made jointly by the host, who must be an APS member, and the visiting scientist. The recipient receives funds generally not exceeding \$5,000. The size of the award depends on the estimated needs over and above the amount already available to the visiting scientist. For scientific visits beginning between January 1 and June 30, the application is due on October 15 the year before with notification by December 15. For scientific visits beginning between July 1 and December 31, the application is due on April 15 of the same year with notification by June 15.

The Lazaro J. Mandel Young Investigator Award

- Established in 1999 in memory of Lazaro J. Mandel, professor of physiology at Duke University and long-standing APS member. The Award is given annually to a member of APS working within the U.S. who holds an academic rank no higher than Assistant Professor. The Award is intended to support an individual demonstrating outstanding promise based on their research program in epithelial or renal physiology. The award of \$10,000 is designated for the use of the Awardee in their research program. The award does not include any indirect cost reimbursement. The recipient receives complimentary registration to attend the Experimental Biology meeting and a certificate presented at the APS Business Meeting held at the Experimental Biology meeting.

The Shih-Chun Wang Memorial Fund

- established in 1998 in memory of Shih-Chun Wang, the Pfeiffer Professor of Pharmacology at Columbia University and a long-standing APS member. Wang was internationally recognized for his research contributions in the areas of neurophysiology and neuropharmacology with an emphasis on brain stem control mechanisms. The Shih-Chun Wang Young Investigator Award is given annually to an individual demonstrating outstanding promise based on their research program in the physiological sciences. Applications are accepted from members of the APS working within the U.S. and holding an academic rank no higher than Assistant Professor. The award of \$11,000 is designated for use in the Awardee's research program. The award does not include any indirect cost reimbursement. The Awardee receives complimentary registration to attend the Experimental Biology meeting and a certificate presented at the APS Business Meeting held at the Experimental Biology meeting.

#### S&R Foundation Ryuji Ueno Award

### Sedgwick Memorial Medal for Distinguished Service in Public Health

- The Sedgwick Memorial Medal, APHA's oldest and most prestigious award, was established in honor of the late Professor William Thompson Sedgwick and was first awarded by APHA for distinguished service and advancement of public health knowledge and practice in 1929. Professor Sedgwick was president of APHA in 1915 and Head of the Department of Biological and Public Health at Massachusetts Institute of Technology from 1883 to 1921. The Sedgwick award, one of the highest honors bestowed by APHA, is a true accolade of the profession the recognition by an individual's colleagues of outstanding accomplishments in the field of public health.

### The APHA Award for Excellence

#### The Helen Rodriguez-Trias Social Justice Award

- Awarded to a person who has worked toward social justice for underserved and disadvantaged populations. This individual's work should focus on improving the health and well being of these populations and should include the activities of leading, advocating and mentoring (any or all three of these activities). This award is named after the late Dr. Helen Rodriguez-Trias, past president of APHA and a pediatrician. Dr. Rodriguez-Trias was an inspiration and role model who strove to meet the needs of underserved and disadvantaged populations, especially women and children. Through her work and activism, she used social justice strategies that affect change for the better. For the purpose of this award, social justice is intended to be seen in the context of improving the public's health and well being through works that lead to the elimination of health disparities. These works, which empower disenfranchised communities toward making healthy changes, and influence public policies toward a greater equitable distribution of resources for those with little or none. Specific areas to be considered for this award are those that deal with cross cultural communications, reproductive rights, women's health issues, and providing access to health care. Priority shall be given to a public health worker whose actions can be viewed as a model for what can be done to address inequities and injustices at national, state, and/or local levels of operations.

The Milton and Ruth Roemer Prize for Creative Local Public Health Work

The citation is not presented every year, but only on occasions of unusual merit. Candidates for the APHA Presidential Citation are nominated by the president of the Association, and the choice is confirmed by the APHA Executive Board.

### Borelli Award

- The award recognizes outstanding career accomplishment and is awarded annually to an investigator who has conducted exemplary research in any area of biomechanics. The awardee attends the Annual Meeting of the ASB to receive the award and to deliver the Borelli lecture. The award consists of an engraved plaque and a check for \$1,500. The Application deadline is the abstract submission deadline for the Annual Meeting.

### Jim Hay Memorial Award

- The Jim Hay Memorial Award recognizes originality, quality, and depth of biomechanics research that address fundamental research questions relevant to extraordinary demands imposed in sport and exercise.

### Goel Award for Translational Research in Biomechanics

- The Goel Award selection is based on originality, quality and depth of the candidate's research, and the commercial and societal benefits emanating from this research. This research is expected to have a biomechanical element. The winning candidate will have demonstrated the translational nature of his or her work from basic research to the enhancement of human health and well-being. The awardee must attend the Annual Meeting of the ASB in order to receive the award. The award consists of an engraved plaque and a check for \$1,000.

### Founders' Award

- The Founders' Award is given to recognize "scientific accomplishment in biomechanics and excellence in mentoring" and is open to investigators of all disciplines within ASB. This is a new award that will be presented in 2017 for the first time. The awardee must attend the Annual Meeting of the ASB in order to receive the award. The award consists of an engraved plaque and a check for \$1,000.

### Young Scientist Post-doctoral Award

- This award recognizes early achievements by promising young scientists who is within five years of receiving their PhD. Selection is based upon the scientific quality of the submitted material. The awardee must attend the annual ASB meeting to present their work in a special awards session. It is expected that the awardee will submit a full-length manuscript for publication in the Journal of Biomechanics. The award consists of an engraved plaque, a check for \$500, and a waiver of conference fees for the annual ASB meeting.

### ASB Junior Faculty Research Award (JFRA)

The purpose of this program is to support early career ASB regular members pursuing biomechanics research by offering a source of research funding. The grants are distributed on a competitive basis and are intended to offset the costs directly associated with conducting research. Funds may be used for small equipment items, materials and supplies, and animal or participant costs, and \$1000 can be used to support graduate student stipends or hourly pay (**as of 2018**), but no indirect costs of research. ASB anticipates awarding one grant of \$5000 for a one-year period beginning in July each year.

### Distinguished Achievement Award

### Early Career Professional Award

Eligibility:

1. 1 to 10 years past date of doctoral degree.
2. Substantial contributions to the fields of career and/or vocational psychology as evidenced by at least one publication on which the nominee is first or only author.
3. Nomination by colleagues, members of the awards committee, or members of SVP as having made a substantial or cutting edge contribution to the field.
4. Demonstration of a commitment to continuing to conduct research in vocational psychology.
5. An active member in SVP.

- The Gerontological Society of America (GSA) fosters new ideas, recognizes leadership in gerontological teaching and service, and salutes both outstanding and potential research through a host of awards. The Society's awards program has a dual purpose; honoring outstanding leaders in the field of gerontology and focusing attention on new developments in the area of aging. In a way, the Society's award winners serve as milestones in the history and development of gerontology. The multidisciplinary breadth of the Society's membership is reflected in the awards maintained by GSA. Some awards honor outstanding achievement in gerontology irrespective of discipline, other awards are limited to each of the Society's four sections or disciplines; Biological Sciences, Behavioral and Social Science, Health Sciences, and Social Research, Policy, and Practice. What follows is a listing of all awards given or administered by the Society.



## Society-Wide Awards

### Donald P. Kent Award

- The Donald P. Kent Award is given annually to a member of The Gerontological Society of America who best exemplifies the highest standards for professional leadership in gerontology through teaching, service, and interpretation of gerontology to the larger society. The award was created in 1973 in memory of Donald P. Kent for his outstanding leadership in translating research findings into practical use.

- The Robert W. Kleemeier Award is given annually to a member of The Gerontological Society of America in recognition for outstanding research in the field of gerontology. - The M. Powell Lawton Award, sponsored by The Polisher Research Institute of the Madlyn and Leonard Abramson Center for Jewish Life, recognizes outstanding contributions from applied gerontological research that have benefited older people and their care. The award was established to honor the memory of the late M. Powell Lawton, PhD, director emeritus of the Polisher Research Institute and a leading figure in aging research. The award is presented at the GSA's Annual Scientific Meeting to an individual who exemplifies Dr. Lawton's personal and professional qualities, and whose contributions in gerontology have led to innovations in gerontological treatment, practice or service, prevention, or amelioration of symptoms or barriers. Individuals who have influenced public policy changes or demonstrated leadership in defining and implementing a creative program that led to improvement in the lives of older persons are also eligible. The awardee receives a \$3,000 cash prize and certificate, and presents a lecture at the GSA's Annual Scientific Meeting the following year. Nominations of candidates in the early or mid stages of their careers are encouraged.

#### The Maxwell A. Pollack Award

- For Productive Aging recognizes instances of practice informed by research and analysis, research that directly improved policy or practice, and distinction in bridging the worlds of research and practice. An individual who is mid-career and actively engaged in the conception and development of innovative programs that demonstrate excellence in translating research into practical application or policy is eligible for this award. The individual should be visionary in his/her approach to meeting current and critical needs of an older population in new and creative ways. The award is presented at the GSA Annual Scientific Meeting. The awardee will also be expected to give a presentation about the program for which the award was received. The award includes a cash award of \$8,600, certificate, travel reimbursement and a symbolic emblem. This award is funded by the New York Community Trust through a generous gift from Maxwell A. Pollack Fund.

#### IAMFC Lifetime Achievement Award

The recipient has devoted countless hours and immeasurable energy to further the organization and the profession it serves. Held in high esteem by colleagues and peers, the recipient has contributed significantly to the professional development of others by providing invaluable mentorship and guidance. The honoree is firmly established as a pioneer of IAMFC, providing extraordinary commitment and leadership to the organization. This momentous award is truly reserved for the best of the best. Letters of nomination for any of the above awards should clearly state the name and email and physical addresses of the nominator, the name and email and physical addresses of the nominee, and the award category for which the individual is being nominated (COMING SOON). Each nomination requires at least two supporting letters. Nominees must be current members of IAMFC.

#### IAMFC Member Research Award

- IAMFC offers annual awards to recognize recent high quality quantitative and qualitative research in marriage, couples, and family counseling, and to recognize recent high quality quantitative and qualitative research in the training and supervision of family counselors and trainees. Nominations may be made by members of ACA, IAMFC, or another division of ACA. Self-nominations are eligible for consideration. ### Howard B. Meek Award

The Howard B. Meek Award is the highest individual recognition a member of ICHRIE may receive. It is presented to an ICHRIE member in recognition of the individual's lifetime contributions and outstanding service both to hospitality education and to International CHRIE. ### The Presidential Award

- Given to an individual or a team of individuals who have made a major specific contribution to prevention science research. This award is intended to be a “lifetime achievement” award for a significant body of research or theory in any area related to prevention that has had a major impact on the field. The award can be for an entire research program extending over many years or for a single study that changed the field substantially. The awardee(s) may represent the fields of epidemiology, statistical methodologies, research design, or prevention strategies including interventions and policies.

The Prevention Science Award

- Given to an individual or team of individuals for a significant body of research that has applied scientific methods to test one or more preventive interventions or policies. This award recognizes individuals for the work of developing and testing prevention strategies.

The Public Service Award

- Given to an individual or team of individuals in recognition of extensive and effective advocacy (to include dissemination and diffusion) for prevention science and science/research-based programs.

The Translational Science Award

- Given to an individual or a team of individuals in recognition for contributions to the field of prevention science in the area of Type 1 or Type 2 translational research.

The Nan Tobler Award

- For Review of the Prevention Science Literature is given to an individual or a team of individuals for contributions to the summarization or articulation of the empirical evidence relevant to prevention science.

The Advances in Culture and Diversity in Prevention Science Award

- Given to an individual or a team of individuals for contributions to the field of prevention science in the area of culture. Recipients of this award are recognized for work to enhance understanding of culture in prevention science and the development of and adaptation of effective prevention strategies for traditionally underserved and/or underrepresented populations, including racial and ethnic minorities.

The International Collaborative Prevention Research Award

- Given to an individual or a team of individuals for contributions to the field of prevention science in the area of international collaboration.

The Service to SPR Award

- Given to an individual or a team of individuals in recognition of outstanding service to the organization.

The Friend of ECPN Award

- Presented to a mid-career or senior preventionist who has supported and encouraged early career persons or issues. The recipient of the Friend of ECPN award will have been active in supporting early career activities, either by helping ECPN as an organization; promoting training, funding, or early career involvement in prevention efforts; or encouraging early career preventionists in their work.



The ECPN John B. Reid Early Career Award

- Presented to a person early in their career in prevention. This award will be bestowed on someone who has shown a commitment to prevention science through outstanding contributions to research, policy or practice.

The ECPN Service Award

- Presented to someone who has shown a commitment to the development and advancement of ECPN. The intention of this award is to recognize contributions above and beyond traditional steering committee responsibilities.

### Early Career Research Award

- This award recognizes a young scholar whose research, publications, grants, conference presentations, and visibility in the field represent a significant contribution to understanding adolescent development and behavior. This award will be made to an early career scholar whose scholarly contributions are distinguished through research, publications grants, conference presentations, and his/her visibility in the field. Nominees should be no more than six years beyond the Ph.D. or equivalent degree, unless exceptional circumstances necessitated a hiatus in their scholarly activities.

### Mid-Career Award for Research Excellence

- Managing the transition from being an early career scholar to a mid-career scholar can be a challenge because demands increase and support often declines. In addition, expectations for more influential scholarship intensify. It is essential for the advancement of our science for scholars to meet this challenge and to continue to expand their research programs. The Society for Research on Adolescence (SRA) seeks to recognize the importance of mid-career scholarship and to celebrate mid-career scholars who exemplify research excellence on any topic regarding adolescence and the transition to adulthood. Nominees must be between 7 and 15 years beyond earning their PhD or equivalent degree (unless exceptional circumstances necessitated a hiatus in their scholarly activities). The nomination letter can come from multiple individuals (with at least one being a current SRA member).

### John P. Hill Memorial Award

- This award recognizes an individual whose overall program of work has had a significant impact on our understanding of development and behavior during the second decade of the lifespan. Letters of nomination to the committee should include a brief statement about the nominee's contributions to the field, including pertinent references to scholarly articles or chapters that represent the nominee's contributions to research on adolescence.

### Outstanding Mentor Award

- Training, guiding, and encouraging early career researchers through direct instruction and collaboration in research are integral components of advancing the multidisciplinary field of research on adolescence. The Society for Research on Adolescence (SRA) seeks to recognize the importance of this capacity-building by honoring members who have made exceptional contributions to the field in general and SRA in particular through their mentoring of the next generation of researchers focused on adolescence and the transition to adulthood. We want to celebrate those who exemplify outstanding mentoring. The nomination letter can come from multiple individuals (with at least one being a current SRA member).

SRA Organizational Award for Excellence in Research and Programming for Youth

- This award honors an organization that has contributed significantly to enhancing scientific research and application of that research to promote the development of young people from diverse backgrounds and in diverse settings. It is awarded in recognition that organizations play a vital role in advancing science and science-based programs and policies that serve young people. Foundations, university-based centers that focus on research and policies relevant to youth, and youth-serving community organizations, among others, are eligible for this award.
