Announcements

- Graduate School update
 - o Introduction from new Interim Dean Deborah Haynes
 - There are currently 444 GRAs if the PI receives a cease-and-desist letter, research
 needs to stop. Do not know how many GRAs will be impacted. If money was already
 distributed, expecting that it can be used for GRAs; if money has not been distributed,

may impact GRA funding. It will fall to the colleges to see if they can work with the student.

- If you have questions about GRA funding, can send to Haynes and she will funnel questions to the appropriate parties.
- o Interim Dean Haynes will be reaching out to schedule meetings with colleges
 - Warnat suggests providing a suggested time for your college's meeting
 - Haynes will be meeting with GSLC tomorrow
- Shorelight contract for recruiting international students. Currently accepting admissions applications.
 - Some international students have shared recent experiences of being turned away at the airport for a variety of reasons (e.g., spices, medications)
 - Students can contact Reeves directly if anything like this comes up
 - OIP provides lists of items not to bring, rules to follow
- Spring graduation applications due today (February 5)
- GradCat Wellness Week next week, encourage your students to attend events
 - Community Dinner: free dinner for graduate students on Tuesday, February 11th from 5-7pm in Rendezvous Dining Pavilion

- There are several Graduate School awards for graduate students, are these still available?
 - These are still active, not federal
 - Have not started reviewing, can still apply this week
- Faculty Senate update
 - o Alison Harmon attending today's FS meeting to discuss federal funding
 - Refer anyone with questions to Alison Harmon's office (Research and Economic Development)
 - Concerns expressed by emeriti faculty regarding losing MSU email address have been addressed— will just have to fill out a form to request keeping their MSU email address
 - o FS continuing to discuss retired faculty serving on graduate committees
 - Open discussion
 - o 2nd reading on the one-credit extension and in absentia policy at upcoming FS meeting

New Business

- Pending policies
 - Appeal policy
 - Concern at FS regarding what could be appealed
 - Concern that a single person could overturn a major academic decision determined by the graduate committee (e.g., defense fail)
 - Concern from graduate students that timeframe is not long enough

- Timeframe was moved to 10 days because often these academic decisions occur at the end of the semester and want to get a timely resolution for the student
- Suggest returning appeal policy to subcommittee for revisions
 - Revise to address concern of appeal criteria
 - Still pending feedback from legal on this issue
 - Review suspended versus dismissed language in the appeal policy language
 - Still pending feedback from legal on this terminology
 - Graduate student feedback is to advocate for a broader policy that gives students more leeway to appeal
 - Students fear retaliation
- Appeal policy will return to policy subcommittee
- Doctoral committee deadline
 - Review proposed policy
 - Sense was that the current policy works well for most programs, does council want to move forward with this policy?
 - Discussion
 - o Encourage students to submit committees as early as possible
 - Can update guidance to encourage students to talk with their graduate coordinator if they are having trouble identifying a committee
 - Dunlop motions to table, Livingston seconds, unanimous approval
 - Doctoral committee deadline policy tabled
- Dismissed v suspended language
 - o Pending feedback from legal
- University Graduate Council bylaws
 - Dean of College of Nursing requested NTT faculty member to serve as a voting member on UGC
 - College of Nursing Dean agreed this would be in the individual's job description and would receive compensation
 - Many nursing faculty are not located on campus; a TT member would have to attend remotely. The proposed NTT member advises graduate nursing students.
 - o Discussion
 - Concern that allowing NTT faculty into these types of roles erodes the fullservice permanent faculty
 - Why are there not TT faculty to run the program?
 - Faculty in nursing are clinical instructors
 - Challenge for college to get TT lines approved
 - Changes the nature of UGC
 - Origin of tenure was to protect academic freedom

- Open to an exception for nursing, but not a change to the bylaws
- How many TT faculty in nursing?
 - o 8 total across 5 campuses
- Suggest NTT member could attend as a non-voting member to provide feedback. If want a voting member, provide a TT faculty member.
- College of Nursing Dean could present case for NTT member to be appointed, then UGC vote on an exception
 - Haynes will invite College of Nursing Dean to attend next meeting
